LGBTQ Victory Fund is non-partisan and endorses hundreds of LGBTQ candidates each year.

Its fundraising support includes bundling contributions for candidates through its national network of donors, organizing fundraising events and promoting candidates through Victory Campaign Board members. Its communications support includes raising the profile of LGBTQ candidates in local and national press and responding when candidates face homophobic or transphobic attacks.
