The most traditional method, bundling contributions through a national donor network to targeted races throughout the country, raises the profile of candidates that might not be able to reach a donor network larger than their local

community. Secondly, the Victory Fund provides technical assistance to candidates and campaign teams on effective campaigning as well as dealing with the media when under attack regarding their sexual orientation. Finally, the Victory Fund directly contributes and invests in independent expenditures that will either promote an endorsed candidate or highlight the differences between the candidates vying for the same position.
